Location

The UK’s best connected industrial zone offering direct connectively by road, rail, sea and air. The premises can be linked directly to the national rain network.

The site has already attracted major commitments from international companies such as SeAH Wind (1.1 million sq. ft plant under construction) and energy giant BP, leading a consortium in the delivery of a 60 acre carbon capture utilisation and storage (CCUS) plant to include power generation.

Infrastructure

From Transport connections to electricity, gas and water supplies, Teesworks is a ready home for large industry.

Teeworks has a high resilience 480MVA electricity supply fed by quadruple connections from National Grid into the site’s private wire network.

Description

The property comprises high bay steel framed storage premises offering large volume economical floorspace with up to 20 acres of external hardstanding.

The premises is equipped with 5, 27–30-ton overhead cranes but these are not certified and would require the tenant to recommission them.

The Landlord will carry out basic refurbishment works to the property including repairs to the external cladding, new LED lighting and installation of loading doors by agreement with the prospective tenant.

Freeport customs zone status means that eligible tenants will receive a range of tariff benefits, including duty deferral while the goods remain on site and suspended import VAT on goods entering the customs zone.


